1. Documentation:

1.1. Technical Documentation v.2. Bed: DMP, DMPA, DMPB, DMPBA. Ruda Śląska 2018.

2. Intended use of the product:

- 2.1. Relevant bunk beds DMP, DMPA, DMPB, DMPBA shall be used in a manner compliant with the manufacturer's documentation.
- 2.2. High bed DMPBA, DMPA and upper levels of other beds are intended for children over the age of 6.
- 2.3. In order to minimise the risk of trapping, the distance of the upper safety railings from neighbouring objects shall not be higher than 75 mm or shall be higher than 230 mm.
- 2.4. The top of the used mattress shall be at least 160 mm below the upper edge of the safety railing.
- 2.5. Institute for Research, Attestation and Certification "OBAC" Sp. z o.o. – as the author of this certificate – shall be notified of any changes to the technical documentation of the subject bunk beds DMP, DMPA, DMPB, DMPBA, changing the technical parameters and operating conditions, with the aim of conducting new tests.
